MEMORANDUM OF ASSOCIATION

1. **NAME:-** The name of society shall be **EHSAS'81 FOUNDATION** (hereinafter referred to as Foundation).
2. **OFFICE:-** The registered office of the Foundation shall remain in the N.C.T. of Delhi, and at present it is at 7/8, Ansari Road, Daryaganj, New Delhi-110002.
3. **OBJECTS:-** The object for which the foundation is established are :-
 - i) To work for the advancement/improvement of society, education, health, prosperity and brotherhood amongst members of the society and to do any other works which are beneficial to the society and mankind.
 - ii) To carry on activities related to education, health, social awareness and support.
 - iii) To provide aid to poor and needy with regard to education, medical treatment and for advancement/improvement of any other objects of general public utility or for the objects mentioned as aforesaid.

To achieve the objects as aforesaid to do the following:

A. SOCIAL

- a) To open found establish, promote, set-up, run maintain, assist, finance, support and / or aid or help in the setting up and / or maintaining and / or running orphanages, widow homes, lunatic asylums, old age houses or others establishments for relief and / or help to the poor, old and infirm people and / or destitute(s).
- b) To give, provide and / or render help and assistance to and / or implement and scheme for providing livelihood and up-liftment for the poor.
- c) To give provide and / or render, help and assistance in cash or kind to poor and / or destitute people, windows, etc.
- d) To give provide and / or render food medicine and other help and / or assistance to any shape or form to the poor deserving and needy persons.

- e) To give, provide and / or render monetary and / or other help and assistance for the relief of persons affected by natural and other calamities such as flood, fire, famine, cyclone, earthquake, storm, accident, pestilence, draught, epidemic, unbearable. Cost of living and the like and to give donations/subscriptions or contributions, establishments, centres, or persons doing relief work on such occasions.
- f) To start, maintain and assist any relief measures in those parts which are of or become subjected to natural calamities such as flood, fire, draught, , cyclone, earthquake, storm, accident, pestilence, etc.
- g) To give, provide, distribute among poor, people dhotis, blankets, rugs, woolen clothing, quilts of cotton, woolen, silk or other varieties of clothes or other articles of dire necessity.

B. EDUCATIONAL

- a) To open, found, establish, promote, run , maintain, assist, finance, support and / or aid or help in the setting up and / or maintaining and or running school, colleges lecture hall, reading rooms and other establishments or institutions for advancement of education and improvement of knowledge in arts, crafts, science, computer, literature, humanities and all other useful subjects in all their manifestations.
- b) To open, found, establish, promote, set-up maintain, run , assist finance, support and / or aid /or help in the setting up and / or maintaining and / or running of hostels, boarding houses, gymnasium and other training and vocation institutions for use of students.
- c) To, promote, advance and encourage and / or aid in helping, promoting, advancing and encouraging primary, secondary and higher education including technical and medical education, also physical training, training of handicrafts and useful crafts among the public.
- d) To grant, pay or give scholarship, stipends, prizes, rewards, allowances and other financial assistant or help in cash or kind to students with a view to help them in pursuit of their studies in schools, colleges, educational institutions, technical institutions, art schools, institutions teaching

commercial and other arts, including teaching of cultural arts or other training, research or educational institutional work in India.

- e) To foster and encourage education and training in handicrafts among women folk in general and establish and found institutions imparting such education and to establish, maintain, support, support, or help by monetary gifts or otherwise, centres and institutions for women and children and to provide social welfare works for women and children.

C. HEALTH

To open found, establish, promote, set-up, run, take over, conduct, hold, maintain, assist, finance, support and / or aid or help in the setting up and / or maintaining and / or running hospitals, charitable dispensaries, maternity homes, child welfare centres, convalescent homes, sanatoriums, hostels and other similar institutions or centres for rendering or providing medical relief to the suffering humanity and for research centres and institutions for promotion of research and education for medical science including surgery.

D. GENERAL

- a) To create, promote, and foster healthy and intelligent interest among the public and to encourage friendly feeling and unanimity among them on all subjects conducive to their common welfare and promote, protect and safeguard their rights and interest and to work for their welfare.
- b) To open, found establish, promote, set-up, run, maintain, assist, finance, support and / or aid or help in the setting up and /or maintaining and / or running centres for mental, physical and moral uplift, gymnasiums, playgrounds and parks for public use and other social welfare work and / or activities.
- c) To open, found establish, promote, set-up, run, maintain, assist, finance, support and / or aid or help in the setting up and /or maintaining and / or running of institutions, centres, auditoriums and the like for welfare services to the public and to provide meeting room for socially useful activities and functions.

- d) To open, found establish, promote, set-up, run, maintain, assist, finance, support and / or aid or help in the setting up establishments maintaining an / or running of Dharamshalas and other places for social functions, wells, deep tube wells, tanks, roads, etc, for general public use.
- e) To promote, assist and / or maintain all activities by whomsoever carried in India in conformity with the objects and as are conducive to the well being and general welfare of the society or are conducive for advancement of any object or objects of general public utility.
4. If any one or more of the objects specified in cl. 3 of these presents are held not be objects of public charitable nature, the members of the foundation shall not carry out such object or objects as if the same are not incorporated in these presents but the validity of the foundation created by these presents as a society for public charitable purpose shall not be affected in any manner.

5. **APPLICATION OF FUNDS :-**

The fund, income and property of the foundation will be applied solely for the promotion of the objects of the foundation as set forth above and no portion thereof shall be paid applied or transferred directly or indirectly by way of dividend, bonus or otherwise by way of profit to the members of the foundation or any other person claiming through any of the members provided that nothing herein contained shall prevent the payment in good faith of remuneration or reward to any officer, employee or servant of the foundation or to any member of the foundation or other persons as return for any services rendered to the foundation.
